RE: Complaint of Thelonious Jones, ACRB File #16-051

Dear Chief Turner:

Please be advised that the Atlanta Citizen Review Board (ACRB) has concluded its investigation and adjudication of the complaint filed by Thelonious Jones alleging that on March 29, 2016, the following occurred:

- (1) Atlanta Police Officer Tresa Norwood (Unique ID #2939) was rude and unprofessional towards him. Mr. Jones further alleges that Officer Norwood did not conduct an adequate investigation of the incident when she failed to complete a report and not properly identify any of the involved parties;
- (2) Mr. Jones further alleged that on said date, when he called the Zone 4 precinct to obtain Officer Norwoods' badge number, Atlanta Police Officer Zachary Bambrey (Unique ID #2561) was rude and refused to provide the requested information.

The Board determined the following:

- As it relates to **Officer Norwood**, the Board assigned a finding of **Sustained** for the allegation of **Appropriate Action Required** and recommends that Officer Norwood received an oral admonishment as penalty.
- As it relates to Officer Bambrey, the Board assigned a finding of **Not Sustained** for the allegation of **Appropriate Action Required**.

The file is available for review upon request. The ordinance requires that the Chief respond in writing regarding which recommendations are accepted, rejected, or will be implemented with modifications within thirty (30) days of the submission of a recommendation for action by the Board to the Chief (see Sec. 2-2211(O) of the Ordinance 07-0-0141).
