Dear Chief Shields:

Please be advised that the Atlanta Citizen Review Board (ACRB) has concluded its investigation and adjudication of the complaint filed by Louise Solomon alleging that on January 30, 2017, when Atlanta Police Officer Michael Searcy (Unique ID #4368) responded to her residence at 752 Lillian Avenue S.W., involving a dispute between her and her neighbor, Officer Searcy was rude, argumentative and unprofessional towards her. Ms. Solomon further alleges that Officer Searcy did not take appropriate action when he failed to write a report pertaining to this incident.

The Board determined that the **Conduct allegation** against Officer Searcy be assigned a finding of **Not Sustained**. The Board further determined that the **Appropriate Action Required allegation** against the officer be assigned a finding of **Exonerated**.

The file is available for review upon request. The ordinance requires that the Chief respond in writing regarding which recommendations are accepted, rejected, or will be implemented with modifications within thirty (30) days of the submission of a recommendation for action by the Board to the Chief (see Sec. 2-2211(O) of the Ordinance 07-0-0141).
