RE: Complaint of Robert Hughes, ACRB File #16-094

Dear Chief Shields:

Please be advised that the Atlanta Citizen Review Board (ACRB) has concluded its investigation and adjudication of the complaint filed by Robert Hughes alleging that on April 26, 2016, Atlanta Police Officer Loubens Lundi (Unique ID #4945) falsely arrested him and abused his authority as a police officer. Mr. Hughes further alleged that Officer Lundi called him an “asshole.”

The Board determined that the **False Arrest, Abuse of Authority and Abusive Language** allegations against Officer Lundi be assigned a finding of **Sustained and recommends that the following penalty be imposed:**

- As it pertains to the False Arrest and Abusive Language allegations, it is recommended that the officer receives a written reprimand and training on APD’s Arrest Procedures (APD.SOP.3030) and De-escalation;
- As it pertains to the Abuse of Authority allegation, it is recommended that the officer receives a three (3) day suspension.

The file is available for review upon request. The ordinance requires that the Chief respond in writing regarding which recommendations are accepted, rejected, or will be implemented with modifications within thirty (30) days of the submission of a recommendation for action by the Board to the Chief (see Sec. 2-2211(O) of the Ordinance 07-0-0141).
